President, 'Satyaniketan'



Advocate Mr. M. N. Deshmukh is a prominent advocate, Philanthropist and Social Worker, holding Key Positions in many organizations. He has done tireless efforts and selfless service for the upliftment of the Tribal People living in the interiors of Maharashtra.

Born on September 1, 1940, Adv. M.N. Deshmukh spent his childhood in Mumbai, completed his primary, secondary and higher education in Mumbai. It was his father's wish that his son should become a lawyer. After completing graduation in Arts Faculty he successfully completed L.L.B. (Bachelor of Legislative Law) course, started practice in Bombay High Court. Today he is renowned advocate and notary in Bombay High Court. He can speak Marathi, Hindi, English, Gujrathi and Bangla languages. His concern for building social awareness has resulted in him working in different capacities.

Adv.M.N.Deshmukh created and is the Sponsor of "Nanasaheb Vithoba Deshmukh, Vridhhashram" at Village, Kelungan, Tal Akole, Dist Ahmednagar. This area is thickly populated with very poor tribal people. Many people here are unable to provide basics and elders in such homes become neglected. Adv M. N. Deshmukh has made this old-age home, of 18000 square feet with most modern amenities where 50 elderly people stay free of cost with their meals, clothing and medical expenses completely being taken care of by him-

Facilities at Old Age Home:

- Modern residential building with up to date facilities.
- Separate dorms and toilets for men and women.
- Individual cupboards and side tables.
- Regular health check-ups, 24x7 doctor and in house dispensary.
- Regular diet chart maintained for all.
- Fresh vegetables provided from our own garden.
- Utmost hygiene maintained while cooking.
- Dedicated staffs for routine activities and caretaking.
- Secure premises with CCTV, security personnel and compound walls.
- Premises cleaned and maintained every day.
- Solar panels, wind mills and DG sets.

- Landscaped Gardens.
- Temple in the premises.
- Car parking.
- Goshala with Cows, that gives fresh milk for the elderly.

Adv. M.N. Deshmukh is the suppoeter and patron of various educational organizations in the tribal area in Akole Taluka, Ahmednagar District, Maharashtra.

✚ Adv M.N. Deshmukh is the Founder, Trustee & Patron of “**Adv. Manohar Nanasaheb Deshmukh College of Arts, Science and Commerce**” situated at Rajur, Taluka - Akole, Dist:- Ahmednagar. There was no college in this 100 km remote & hilly region, so tribal children could not pursue education after class 12. He sponsored a college in 1993 built on 12.5 acres area with a modern building, well equipped laboratory, Olympic size pool, Gymnasium, Library, separate hostel facility for boys and girls. There are 1600 students with streams of Science, Arts and Commerce, Tourism, Soil and Water management in the college. **80% of the students are from SC and ST community, 14 % are OBC and NT and 6% are from general category.** Savitribai Phule Pune University has awarded ‘**Best College Award**’ to the College in 2005. College has received several reputed awards such as-

✚ For the great efforts done Adv. M. N. Deshmukh Sir received “**THE JEEVAN SADHANA GAURAV PURUSKAR**” by Savitribai Phule **UNIVERSITY of PUNE** on 10th Feb 2017 for having rendered higher education facilities in the tribal area of village Rajur, Taluka -Akole, District- Ahmednagar.

✚ Adv M.N. Deshmukh is also The President and trustee of “**Satya Niketan**”, an institution started in 1956 for the upliftment of the **Adivasi People** in Akole Tahasil, Dist Ahmednagar, Maharashtra. Initially there was only one school up to class 10th and later class 11th and 12th was started. Currently there are 04 schools in which 3000 Girls & Boys are studying and 700 students are residing in the hostel facility where stay & all meals are provided to them free of cost.

✚ He also started a “**Stri Aadhaar Kendra**” in 1993 along with a crèche facility, from which 700 ladies have got rehabilitated till date. In the rural area there is a huge issue of women being deserted by their husbands post marriage, unwed mothers, handicapped ladies and widows. At the Aadhaar Kendra there is a facility for residing, meals and in addition they are taught various skills like computer, sewing, cooking, making varies crafts so they can independently earn a respectable

living. Efforts are made to get jobs for them, send their kids to school and also get them back to their families after proper counseling is done.

- ✚ Advocate M. N. Deshmukh Sir is the President of **Ambika Yoga Kutir** since 15th August, 1985 and the said organization is having its center office at Thane. It has almost **90 branches all over Maharashtra** with **2500 qualified Teachers**. Besides the branches in Maharashtra and Goa it has also branches in **Dubai, United States Of America, Canada, Mauritius as well as Australia**.
- ✚ **Ayush Ministry of the Government of India** has given due recognition for **spreading Yoga** and that they have been entrusted to sponsor Yoga activities in 4 regions i.e. **Mumbai, Goa, Satara and Sindudurga**.
- ✚ Besides being President of the said Organization, he himself is practicing Yoga both in the morning and evening since last more than **30 years**.
- ✚ It is the late Hon'ble Nikam Guruji, the founder of Ambika Yoga Kutir, who himself has appointed Advocate M.N. Deshmukh as the perpetual President of the said organization taking into consideration his services to the public at large and to the said organization.
- ✚ Mr. Deshmukh, through the said Yoga Organization have started the work of setting up a Yoga Naturopathy & Medical Plant Center at village Kelungan, Taluka - Akole, District - Ahmednagar and for that he has donated **8 Acres** of land in the said place. The naturopathy centre will have a PanchKarma centre, Yoga hall, Dhyana kaksha, Goshala, Solar Energy system, a Bio Gas plant and Medicinal plants in 3 - 4 acres as well as 50 cottages which will provide residential accommodation for 100 people.
- ✚ Shri Deshmukh has also sponsored and maintains "**Smt. Anusayabai N. Deshmukh Dharamshala**" at Trimbakeshwar, Nasik District as well as a **Dharamshala in Pandharpur** of Maharashtra state.
- ✚ He is also a trustee of the famous "**Agasti Mandir trust**" at Akole Tal, Dist Ahmednagar.
- ✚ He has started the "**Talim Sangh**" at Rajur to promote wrestling as this had become a vanishing sport, within a short time the boys of this institution have reached up-to State Level.
- ✚ He has organized and sponsored **blood donation camps, free eye operation camps, free camps for handicapped persons, tree plantations**, and has done tireless effort for water conservation.
- ✚ Adv Deshmukh provides free **legal assistance** to poor and needy people.

Apart from the above charitable activities Adv. M.N. Deshmukh is very active and has done the following social services as well-

- ✚ Adv M.N. Deshmukh founded the **Mulund Gymkhana club** for promotion of sports by providing monetary assistance. He has been the founder member, and has worked as a managing committee member for last 18 years. He is currently a **trustee** and the **President** of the institution.
- ✚ Adv M.N. Deshmukh founded "**THE CONSUMER'S GUIDANCE AND PROTECTION SOCIETY, MULUND**" in 1992 and is currently the President. Besides imparting guidance to needy people, this organization is redressing the grievances of poor people who are being looted by businessmen.
- ✚ He is an Honorary Member of the "**Human Organ Transplant Committee**" at **Fortis hospital**, Mulund Mumbai
- ✚ In addition to the above Adv Deshmukh is the Adviser to various educational Institutions in Mumbai.
- ✚ Adv. Deshmukh Sir has received over **70 awards and trophies** for his noble deeds by many institutions. He has been felicitated by multiple bodies of national and international fame for the tireless efforts done by him.
